2. **Title of the Proposed programme :** 1st Acharya Prafulla Chandra Roy Conference - West Bengal Science and Technology Start-up & Entrepreneur Mentorship meeting through Bengal Business Interface
3. **Target Group :** West Bengal based first generation entrepreneurs and start-up founders, West Bengal based business-persons, Government stakeholders. Total participation and audience - at least 150.
4. **Duration :** 1 Day ; **Tentative Date of the Proposed programme :** 21st June 2026
5. **Aims, Objectives and Details of the Programme :**

With a focus on start-ups and entrepreneurship that are science and technology based, the One-Day conference is aimed at bringing together 30 new entrepreneurs and start-up founders of West Bengal who have set up their venture within West Bengal with established business leaders of West Bengal. The core of the conference will be rapid presentations by the Start-Up founders and Entrepreneurs and they will be judged and given feedback by an expert team of Business leaders. Bangla Pokkho Charitable Trust (BPCT) has tied up with Bengal Business Council (BBC) for this endeavour. Apart from this, there will be relevant sessions which would be useful to budding S&T entrepreneurs and start-ups as well as a lecture of the Business Philosophy for Bengal as enunciated by Acharya Prafulla Chandra Roy. Special endeavour will be made to represent entrepreneurs and start-ups from all over West Bengal and disadvantaged sections of society in West Bengal, especially women. Special focus will be given to first generation entrepreneurs and start-up founders.

**Aim of the Programme :**

West Bengal is about to encounter a Start-Up revolution and S&T start-ups are leading the way. This goes against the age-old myth of aversion to entrepreneurship in Bengal. Taking inspiration from Acharya Prafulla Chandra Roy, whose single-minded mission was development of business and entrepreneurship in Bengal, this conference aims to gather and boost emerging S&T start-ups in West Bengal.

West Bengal's startup ecosystem is growing rapidly, with a four-fold increase in DPIIT-recognized startups since 2019. The West Bengal State government's supportive policies, strong talent pool from premier institutions, and lower operational costs are key drivers of this emerging hub.

- **Significant Growth:** The number of DPIIT-recognized startups in West Bengal has dramatically increased, reaching over 5,240 as of early 2024.

- **Kolkata as the Epicenter:** Kolkata is the primary hub, ranking 9th nationally and #187 globally in the StartupBlink Ecosystem Index, with a 45.6% annual growth rate in 2025.
- **Supportive Government Policies:** The [West Bengal Startup Policy](#) offers financial assistance, mentorship, and infrastructure support to entrepreneurs.
- **Diverse Key Sectors:** Startups are emerging in various sectors, with foodtech, fintech, e-commerce, healthtech, AI, and manufacturing showing particular promise.
- **Strong Talent Pipeline:** The presence of prestigious institutions like University of Calcutta, ISI Kolkata, IIT Kharagpur, IIM Calcutta, and Jadavpur University provides a rich talent pool, fostering innovation and entrepreneurship.
- **Focus on Manufacturing:** The state government actively promotes manufacturing startups through various schemes, leveraging the availability of raw materials and skilled labor.
- **Infrastructure Development:** The development of new IT parks and incubation centers, such as the Bengal Silicon Valley Tech Hub, aims to enhance tech infrastructure and attract investment.
- **Access to Funding:** Initiatives like the West Bengal MSME Venture Capital Fund and a network of angel investors aim to address the historical challenge of limited access to capital.
- **Beyond Kolkata:** There is a growing focus on decentralizing entrepreneurship to tier 2 and tier 3 cities like Siliguri, Durgapur, and Asansol, to spread innovation across the state.

**Objectives of the Programme:**

Conference has following key objectives:

1. To mentorship and competitive assessment of S&T centric Start-ups and budding Entrepreneurs of West Bengal.
2. To provide interface between business leaders of Bengal via tie-up with Bengal Business Council and the S&T centric Start-ups and budding Entrepreneurs of West Bengal.
3. To expose wannabe entrepreneurs of West Bengal to this event that brings together budding entrepreneurs and established business leaders.

4. To appraise business leaders of Bengal, budding entrepreneurs of Bengal and wannabe entrepreneurs to the philosophy of S & T based entrepreneurship of Acharya Prafulla Chandra Roy.
5. This is intended as a pilot event and lessons from it will be replicated regularly in various locations of West Bengal. So we want to frame Standard Operating Procedure of conducting such a S & T start-up conference from the experience of this flagship event.
6. To provide a report on the conference to the Government of West Bengal based on presentations, discussions and feedback from the workshop.

#### **Details of the Programme :**

Venue of the conference will be a hall of 300+ capacity in Kolkata with stage and projection facilities. The programme duration will be one day and will go from morning to evening. The Language of the whole programme will be in both Bangla and English, as per convenience of speakers.

It will consist of the following items

Welcome lecture by Dr. Garga Chatterjee, PhD ( Harvard) and Managing Trustee of Bangla Pokkho Charitable Trust on the Business Philosophy of Acharya Prafulla Chandra Ray.

30 presentations of developing business and new business plans and ideas by 30 S&T based Start-ups and Entrepreneurs of West Bengal. Each presentation will be 4 minutes with 1 minute of buffer time.

Presentation specific feedback for each participant by a team of established business leaders of Bengal, consisting of members of Bengal Business Council - West Bengal's premier chamber of commerce. The expert team will include : Owner of Chandra Chemicals and Dendrite brand, Owner of dairy giant Red Cow, Owner of food tech giant Mukhorochak and various other business leaders.

Question and Answer session - Panel of established business leaders of Bengal will respond to questions from registered participants who want to initiate start-ups.

Closing Motivational lecture by Mr. Avishek Auddy, President of Bengal Business Council. Mr. Auddy is also the owner of Chandra Chemicals and adhesive brand Dendrite.

Felicitations of the 30 start-ups and special memento presentation for those ranked Top 5 by the expert panel of business leaders of Bengal.

Interested members of the public may attend after paying a registration fee to cover lunch and kit expenses. Certificate of participation will be provided.



**3. PLACE OF THE TRUST:**

The Trust shall hold its registered office at **7/1, Chetla Road, Flat No. 3E, P.S. Chetla, Kolkata- 700027**, and it may shift to any other place within the territories of India if the Board of Trustees desires.

Branch office/officers, if deemed necessary, may be opened at any other place/ places in India as the board of Trustees may deem expedient and proper in accordance with the decision taken by the Trustees from time to time, provided the activities and operation of the trust shall be within the Union states and Union Territories of India.

- i) To print, publish, sell, and distribute useful literature in CD, Floppy, Newspaper, Magazines and other media formats.
- j) To promote and encourage advancements of Bengali literary and Bengali cultural education.
- k) To promote and find out various marginal voices in the Bengali community as a whole.
- l) To help the handicapped, helpless and destitute, internally, internationally homeless people, children of all communities, especially that of Bengali community for their better future.
- m) To organize acting, music, dancing and mine course for the disadvantaged and other people.
- n) To help the children, women and other destitute men and women for them to stand at their own feet by persuading various activities like income generation, health and others by giving them various cultural training in Bengali Nationals spread throughout the Territory of India.
- o) To acquire, purchase and take on lease or otherwise and hold lands, buildings and properties of every description in the name of the Trust for furthering the objects.

- t) To establish and operate centers for promotion of art and culture of Bengali.
- u) To engage in philanthropic works in case of any natural calamity and to help the needy people of the Trust.
- v) And to do all other things as are incidental to fulfill the above objectives or anything new that may come forward.

## 5. PROHIBITION:

- a) The Trust shall not take up any objects of the Trust for the purpose of profitable earning for its Trustees or involve and carry out any profitable activity.
- b) The objects shall remain restricts within the scope of The Indian Trusts Act, 1882.
- c) The refuge of The Indian Trusts Act, 1882 has not been taken to avoid the application of Registration under any other Act.
- d) The income or the assets of the trust fund shall not be applicable or transferred at any time in whole or part thereof for any purpose other than the activities mentioned within the preview of the objects of the trust.
- e) The income or assets of the trust shall not be applied or used for the benefit of the authers of the trust or any person who make substantial contributions or donations to the trust or any trustee or manager of the trust.

f) This Trust will not be in any way merged or amalgamated with any other Trust or Society.

#### 6. **BOARD OF TRUSTEES AND MEETINGS:**

a) The Trust shall be administered by a Board consisting of not less than 5(five) and not more than 8(eight) Trustees. The Board of Trustees shall hold office for a period of 3 years.

b) The present Trustee shall be the First Trustees and the Trustees for the time being shall be entitled to appoint such person/s of their discretion as Trustee/s provided that at no time the total number of Trustees shall exceed Eight.

c) The First Trustee shall retire on 21<sup>st</sup> day of June, 2023 and shall be eligible for re-appointment.

d) After the expiry of the term of the Board of Trustees the formalities of forming new board of Trustees must be completed by 21<sup>st</sup> Day of September, 2023 of the year in which the term of the board of trustees expires so that new trust board may resume its office from 21<sup>st</sup> Day of November of the said year.

e) Office bearers will be elected by the trustees amongst themselves after the election of board of trustees within fifteen days of election of board of trustees.

f) Board of trustees shall hold at least one meeting in each quarter of the year and proceedings of the meeting will be duly recorded in a Minute Book.

g) Notices and other procedures of the meeting of the Board of the Trustees and General Meeting may be frame by the trustees in their meetings.

h) Before assuming office or taking part in any meeting a newly appointed Trustees shall give him consent in writing to act as such as a trustee. A trustee shall be deemed to have consented in case he attends any meeting of the Board of Trustees and signs the attendance book or does any act as Trustee after being so being so nominated or appointed.

i) In all meetings Two Trustees will form QUORUM and the senior most shall be the Chairman.

- j) A question arising at the meeting of the Trustees shall be decided by majority vote and in case of equality of votes the chairman shall have the second vote or deciding vote provided, however, that no question touching the disposal of the corpus or part thereof or any of the immovable properties will be decided and disposed off except in accordance with the votes of 3/4<sup>th</sup> of the Trustees.

## 7. POWERS AND DUTIES OF TRUSTEES:

The Governing Body shall have the following powers and duties for efficient management of affairs of the Trust:

- a) To appoint employees to the Trust on such terms and contract as may be determined by the trustees with consent and approval of all other trustees.
- b) To form Subcommittees for specific purpose for the fulfillment of the objects of the Trust.
- c) To organize processions, sabhas, meetings, conventions, jatras, street plays, exhibitions, dharnas, seminars, etc.
- d) To open found, establish, promote, setup, run, maintain, assist, finance (not in the form of loan), support or aid or help in setting up, institutions, libraries, meeting/conference halls, bodies, trusts ,old age homes, orphanage, etc.
- e) Publish, assist, finance (not in the form of loan), support or aid in publication of books, pamphlets, newsletters, audio and video cd's, reels, tapes.
- f) Maintain, assist, finance (not in the form of loan), support or aid in maintenance of websites.
- g) Actively lobby, send memorandums, suggestions, seek information from local, state, National or Global bodies and their members/servants/leaders.
- h) To collect the dividends, interests, rents, Profits and all other incomes of the Trust Funds (hereinafter for brevity's sake called "The Income of the Trust Funds") and from out of the same, in the first place, pay all the proper costs, charges and expenses of the trust from the trust funds and incidental to the collection

- i) To generate fund by accepting gifts, donations, grants, contributions, assistance, subscription in cash or any kind from any person, company, firm, association, HUF family trust or corporate body, Society's institutions Government or Semi Government organizations and departments and to acquire property both movable and immovable in the name of the trust for perpetuating the existence and activities for the furtherance of the objects of the Trust.
- j) To manage the properties and other assets of the Trust for the time being and do all such acts necessary for the preservation, maintenance and management of the properties of the Trust.
- k) To make a Gift of any property movable or immovable belonging to the Trust to any institution, society or Trust established in India or outside India for a charitable purpose or objects similar to that of the Trust.
- l) To remain duty bound and vigilant about all statutory requirements of the Trust.
- m) To borrow or raise money for carrying out the objects of the trust by any one or other means as the Trustees may think fit and proper.
- n) To purchase, construct, let out, lease mortgage, sell or give on rent or on hire or otherwise deal with any immovable property on behalf of and in the name of the Trust as the Trustees think fit and proper in their discretion.
- o) To open any/all types of Banking Accounts whether current, savings, fixed or any other mode in the name of the Trust with any scheduled bank/s and shall be operated by any two Trustees authorized by the Governing Body.
- p) The Trustees are authorized to give guarantee and securities to any person, corporate bodies, institutions including Government or semi Government departments as Trustees may deem fit and proper in the interest of the Trust. The Trustees shall not be liable personally for such guarantee or security otherwise than willful negligence.

- q) To adjust, settle, compromise, compound or refer to arbitration all action suites claims, demand and proceedings or any matter arising in connection with the working of the Trust.
- r) To appoint lawyers, pleaders, advocates to file and defend suites filed for or against the Trust and/or in the name of trustees relating to the trust and file suit for realization of money/ies or other dues of the Trust and sign and execute such applications, petitions, plaints, documents for such proceedings and delegate such power/s to any person/s for such proceedings as required from time to time.
- s) To appoint employees of all nature including executive, professionals, experts for the management preservations and maintenance of Trust and its properties and for furtherance of objects and to delegate than such duties and powers to the persons as the Trustees think fit and proper.
- t) The Trustees will have power to undertake programs and draw schemes/s for furtherance of objects of the trust and may appoint and constitute committees, sub-committees, as the Trustees think fit and proper and also to make such rules and regulations for such committees. These committees may maintain separate accounts including Bank accounts in the name of the Trust but the Trustees shall operate such Bank Accounts and such committees will work under the guidance of Trustees and shall keep informed of all activities to the board of Trustees.
- u) To transact all other business that may come up in different situation.

#### **8. FUNCTIONS OF THE TRUST:**

The functions of the trust are stated as under:

- a) The Trust will never get involved/ encourage/ entertain/ tolerate any such activities that are unlawful in the eye of law. It will oppose such activities that are contrary to the law of the land and take necessary and strict actions that may deem fit, against the offender according to the Indian Penal Code. - b) The Trust will not act as a financial credit supporter like Micro Financing, Micro Credit, Franchise and will not get involved in any Money Laundering activity (Prevention of Money Laundering (Prevention) Act, 2012) and any economic offence/crime in nature and shall not accept any donation/funding from external sources and foreign countries (Foreign Contribution (Regulation) Act, 2010) without the permission and authorization from the competent Government Authority. If any such activities, herein mentioned above, occur without any valid authorization from any competent authority, the Trust and the Trustees are to be solely responsible for the same and the Trust will be declared as VOID and will face trial under appropriate legal forum according to the Indian Penal Code.
- c) That at present the Trust has no immovable and landed property save and except the Trust Fund amounting to Rs. 10,00,000/- (Rupees One Lakh) Only in its own name and no immovable and landed property is being settled in favour of this Trust by this documents.
- d) That Trust will never acts like Money Laundering (Act 2012) in nature and shall not obtain any donation or like that from abroad without permission of the FCR Act from the Central Government/ the competent Government authority.
- e) All money forming part of the Trust, fund requiring investments shall be invested and the conveyance of assurance in respect of any immovable property/ properties forming part of the Trust Fund shall be obtained in the name of the Trust.
- f) It is also clarified that the Trust shall not make any dividend, gift or divide bonus in money to any of Trustees by way of profit and the entire income or property of the Trust shall be applied solely for the aims and objectives of the Trust.

## 9. **FUNDS:**

The bank account shall be operated by the Managing Trustee along with any one of the remaining Trustees.

## 11. **THE MAINTENANCE OF AUDIT AND ACCOUNTS:**

The Indian Trusts Act, 1882 shall be strictly followed in relation to accounts and audit.

- a) **Accounting Year** – The accounting year of the society shall be the financial year commencing from 1<sup>st</sup> April of a year to 31<sup>st</sup> March of the following year.
- b) **Auditors** – The account shall be audited by a Chartered Accountant or a qualified auditor as defined in The Indian Trusts Act, 1882, who shall be appointed for that purpose by the Trustees.

#### **12. APPLICATION OF INCOME TAX:**

THE TRUST fund the same shall be applicable and applied to for PUBLIC CHARITABLE PURPOSE ONLY within such territories and subject to such conditions or limitation if any as may from time to time be laid down by the Income Tax Act or any other acts governing taxation of income, the wealth of Public Charitable TRUST as so to render under Act/s, now or prevailing or any modification replacement thereof.
- ii. To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST to which provisions of section 80G/12A/FCRA/35AC/10(23C) IV / V/ VIA of the income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donations or contributions thereto is recognized as eligible for exemption or relief from tax in the hands of the donor.

#### **13. AMALGAMATION:**

It was written earlier that the Trust will never be amalgamated.

#### **14. DECISIONS BY TRUSTEES:**

It will be the endeavor of the trustees to take all decisions unanimously. However, in case of any difference in opinion among the trustees, if there is more than one trustee, the opinion of the majority shall prevail.

**18. APPLICABILITY OF TRUST ACT 1882:**

The provisions of THE INDIAN TRUST ACT, 1882 SHALL APPLY TO ALL MATTERS NOT SPECIALLY MENTIONED IN THESE PRESENT, violation of which in any part, the Trust will be VOID.

**19. LAWFUL PURPOSE:**

A Trust may be created for any lawful purpose. The purpose of a Trust is lawful unless it is:

- a) Forbidden by law or,
- b) Is of such a nature that, if permitted, it would defeat the provisions of any law, or
- c) Is fraudulent, or
- d) Involves or implies injury to the person or property of another, or

e) The Court regards it as immoral or opposed to public policy.

Every Trust of which the purpose is unlawful is VOID. And where a Trust is created for two purposes, one of which is lawful and the other is unlawful. The two purposes cannot be separated, the whole trust is void.

#### **20. DISSOLUTION OF THE TRUST:**

In the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the Trustees but the same shall be transferred to another similar Trust/ Organization whose objectives are similar to those of this Trust with the permission of the Charity Commissioner / Court or any other competent authority as may be applicable for the time being.
